Among the open questions has a fundamental role the opportunity to identify ways to contribute to the social and economic contexts that need development, including those related to cultural heritage; to intervene on issues related to health, safety, sustainability, enhancement of existing assets.

She has been involved and work on several international and national research projects (Erasmus Plus, Urbact, Prin, etc.) and she is responsible of several research activities (technology transfer) on behalf of a third party (companies, municipality, social institutions, etc.) on the topics of social design, design for environment and health, cultural heritage, and recycle, reuse, circular economy.
